#### Overall Structure of the Program

The Virtual NATO Field School is organized into three types of Modules:

- **Teaching and Engagement Modules**: including lectures, panels, and base visits. Lectures and Panels on the same day occur as separate events.
- **Simulation Modules**: including training and two major exercises (CMX and NMDX) led by retired NATO Defense College Mentors and Faculty Advisors.
- Young Careers: In this module, we bring NATO FS Alumni and other young professionals into the program in mostly informal ways to share their paths towards jobs and careers in the national and international security and defence community.

Teaching and Engagement Modules include:

#### Virtual Base/Facility Visits:

In these segments, an officer or official from a military or political location will walk with us with camera and mic to talk about what the base/facility is, who works there, what they do, how it fits into the larger tasks of Armed Forces and the NATO alliance. All our students are citizens from NATO nations and we realize there are many security provisions for these sites.
